ORDINANCE(S) - SECOND READING & FINAL DISPOSITION

ORDINANCE NO. 07-2018 OF THE CITY OF BURLINGTON AMENDING CHAPTERS 354 (WATER SERVICE) AND 146 (FEE SCHEDULE) OF THE BURLINGTON CITY CODE

WHEREAS, the City of Burlington is a Faulkner Act municipality with a Mayor-Council form of government pursuant to New Jersey Statute 40:69A-31, *et seq.*, with its organization, positions, powers, and duties outlined within the Code of the City of Burlington as set forth pursuant to the Faulkner Act; and

WHEREAS, the City, in consultation with its professionals, have determined that it is necessary to amend and update the City's Ordinances as they relate to metering, monitoring, and other related services; and

NOW THEREFORE BE IT ORDAINED by the Common Council for the City of Burlington that Section 146-17 of the City Code shall be amended, modified, or deleted as follows, with new matter being underlined thus, deletions crossed out ~~thus~~, and any and all other sections or subsections not mentioned herein shall remain as written:

Chapter 354: Water Service

354-6 Rules and Regulations

- A. Installation and Access to all Meters. No meter shall be installed which has not been furnished or approved by the Water Utility Division. All meters shall be under the exclusive control of the Water Utility Division. The City shall from time to time require access to properties in order to read, test, maintain, or otherwise access the water metering equipment and/or connections leading thereto or therefrom, regardless of whether the metering equipment is owned by the City, the property owner, or another entity. The City shall be permitted access for these purposes, and shall notify property owners in accordance with this section:
1. Initial Notice. The City shall notify property owners via certified mail of the need for access to water metering equipment. Such notice shall specify:
 - a. The equipment to which access is required,
 - b. The date by which the property owner must respond,
 - c. The contact information of personnel with whom the property owner may schedule the required access, and
 - d. That failure to reply will result in the imposition of fines and penalties, and may result in the water services being shut off without further notice.
 - e. Property owners shall be given no less than 10 days from the date of receipt to respond.

Follow-up Notice. The City may, at its discretion, attempt additional contact with the property owner via phone, subsequent mailings, and/or in-person visits to the property.

1. Final Notice. Should the property owner fail to respond by the required date, the City shall mail a Final Notice, via certified mail, that access to the property shall be required on or about a specific date, no less than 7 days from the date of the Final Notice.
2. Residential meters shall not go more than 20 years without replacement.
3. Fines and Penalties. Should the property owner fail to provide access by the date outlined within the City's Final Notice, or fail to otherwise comply with this Section, the property owner shall be subject to fines and penalties as per §354-9 of the City Code.

ORDINANCE NO. 09-2018 OF THE CITY OF BURLINGTON AMENDING CHAPTER 162 (FIRE PREVENTION) AND CHAPTER 146 (FEE SCHEDULE) TO AUTHORIZE RECOVERY OF COSTS AND EXPENSES ASSOCIATED WITH PROVISION OF FIRE DEPARTMENT SERVICES

WHEREAS, the City of Burlington is a Faulkner Act municipality with a Mayor-Council form of government pursuant to New Jersey Statute 40:69A-31, *et seq.*, with its organization, positions, powers, and duties outlined within the Code of the City of Burlington as set forth pursuant to the Faulkner Act; and

WHEREAS, the City of Burlington recognizes the Fire Department's need to bill for volunteer fire, rescue, hazmat, and other related services in order to continue their ability to provide a high level of quality emergency response services; and

WHEREAS, in consultation with the Burlington City Fire Department, the fees and charges established within this proposed Ordinance are designed to defer the costs of services, rather than to raise revenue; and

NOW THEREFORE, BE IT RESOLVED, that Chapters 162 and 146 of the Burlington City Code be amended, modified, or deleted as follows, with new matter being underlined thus, deletions crossed out ~~thus~~, and any and all other sections or subsections not altered or mentioned herein shall remain as written:

Chapter 162 Fire Prevention

Article III Emergency Services Cost Recovery

Section 162–30 Authorization to Recover Costs and Expenses

- A. The Common Council of Burlington City authorizes the Burlington City Fire Department and/or the City of Burlington to seek collection and reimbursement for the reasonable costs of responding to fire service calls, hazardous material incidents, environmental incidents, extrication, and other safety, rescue, or service incidents, including but not limited to materials and other related service costs, at the rates established within §146–12(D).

Section 162–31 Billing Policies and Procedure

- A. No person requiring or requesting emergency services from the Fire Department shall be denied services due to lack of insurance or ability to pay.
- B. Any applicable charges as established within §146–12(D) shall be billed directly to the user of such services and/or the user’s insurance company.
- C. The Burlington City Fire Department and/or the City of Burlington shall have the discretionary authority to send notices to the user and/or user’s insurance company for any unpaid or outstanding service charges, and shall have the discretionary authority to pursue collection of any unpaid or outstanding amounts owed under Section 162–30, *et seq.* of the City Code.
- D. Funds collected pursuant to Section 162–30, *et seq.*, of the City Code shall be deposited into the General Fund from the Burlington City Fire Division.

Chapter 146 Fee Schedule

Section 146–12 Fire Prevention

- A. Recovery of Costs and Expenses. As authorized by Section 162–30, *et seq.*, the following charges shall be applied to services rendered by the Burlington City Fire Department:

1. Light rescue. There shall be a fee of \$500 for light rescue operations, including but not limited to batteries, fluid, stabilization, use of hand tools, hazard control, and other scene-related light rescue operations.
2. Medium rescue. There shall be a fee of \$1,000 for medium rescue operations including but not limited to the use of power tools and hydraulic rescue tools to perform activities such as opening or removing doors to provide access to patients, as well as stabilizing vehicles, and performing hazardous assessments.
3. Heavy rescue. There shall be a fee of \$1,500 for heavy rescue operations including any technical rescue procedures, including but not limited to water and ice rescue, rope rescue, confined space rescue, high-angle rescue, trench rescue or structural collapse rescue. Heavy rescue also includes other vehicle rescue where the operation includes the use of power tools and hydraulic equipment to perform operations such as partial or full roof removal, front dash displacement, third door access, and separating vehicles from one another.
4. Discretionary Fees. In the event of a catastrophic, irregular, or other complex rescue effort not adequately represented by the light, medium, and heavy rescue categories, the Department may impose an additional service fee for the purposes of recovering costs and expenses incurred in the subject operation.

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.

ORDINANCE NO. 08-2018 OF THE CITY OF BURLINGTON GRANTING THE COUNTY OF BURLINGTON AN EASEMENT OVER PORTIONS OF PROPERTY IDENTIFIED AS BLOCK 226, LOTS 1.03, 1.06 AND 1.08 AS REQUESTED BY THE COUNTY TO

FACILITATE CERTAIN ROAD WORK NECESSITATED BY THE MATRIX REDEVELOPMENT

WHEREAS, the City of Burlington is a Faulkner Act municipality with a Mayor-Council form of government pursuant to New Jersey Statute 40:69A-31, *et seq.*, with its organization, positions, powers, and duties outlined within the Code of the City of Burlington as set forth pursuant to the Faulkner Act; and

WHEREAS, Matrix Burlington River Road North Urban Renewal, LLC (“Matrix”) has been designated the Redeveloper for certain property within the McNeal Mansion and Vicinity Redevelopment Area, identified as Block 226, Lot 1 on the Tax Map of the City of Burlington (“the Property”); and

WHEREAS, on September 11, 2017 Matrix received minor subdivision and preliminary and final site plan approval from the City of Burlington Land Use Board (“the City Approvals”) for the development of the Property; and

WHEREAS, as a condition of Matrix’s approvals with the County of Burlington (“the County”), the County imposed a number of conditions, including certain off-site improvements to Count Road 656, otherwise known as Pearl Street; and

WHEREAS, in relevant part, these offsite improvements require Matrix to construct an eastbound left turn lane on Pearl Street, for traffic seeking to turn left onto Jones Street; and

WHEREAS, in order to complete the required improvements and provide the road width required by the County, portions of City-owned property will be impacted, requiring the City to grant the County an easement for the widening of Pearl Street; and

WHEREAS, those impacted lots are identified on the Burlington City Tax Map as Block 226, Lots 1.03, 1.06, and 1.08 (“City Property”); and

WHEREAS, the City Property over which an easement is sought by the County are generally undevelopable, and not otherwise needed for City purposes such that the easement would have any negative impact; and

WHEREAS, the specific Easements being requested are identified in the proposed Deed of Easement, attached hereto and incorporated herein by reference as if set forth in full; and

WHEREAS, as a condition of granting the Easement, Matrix, including its successors and/or assigns, shall be required to repair, replace, and maintain the sidewalks and fencing along Pearl Street which will be disturbed as a result of the road widening necessitated by its redevelopment of the Property; and

NOW THEREFORE, BE IT ORDAINED that the City of Burlington hereby authorizes the execution of the attached Deed of Easement to the County for Block 226, Lots 1.03, 1.06, and 1.08; and

BE IT FURTHER ORDAINED that the City's Staff, Administration, and Professionals, as appropriate, shall be authorized to perform all duties necessary to place the Deed of Easement into effect; and

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law; and

RESOLUTION NO. 142-2018 OF THE COMMON COUNCIL OF THE CITY OF BURLINGTON NAMING SKYE CONSULTING, LLC AS REDEVELOPMENT CONSULTANT

WHEREAS, the Common Council of the City of Burlington is the City's Redevelopment Authority pursuant to New Jersey Statutes relating to redevelopment law; and

WHEREAS, the Common Council for the City of Burlington has reviewed the proposal of Skye Consulting LLC, and finds Skye Consulting, LLC to be specialized in having a unique experience, extensive training and experience in redevelopment projects, and a proven reputation in the areas of redevelopment consulting;

NOW THEREFORE, BE IT RESOLVED by the Common Council for the City of Burlington as follows:

- B. Skye Consulting, LLC is hereby awarded a contract pursuant to N.J.S. 40A:11-5 for a period of one year in an amount not to exceed \$60,000.00 (\$5,000 per month);
- C. The Mayor and Municipal Clerk are hereby authorized to execute a contract subject to the review of the City Solicitor with Skye Consulting, LLC for services as Redevelopment Consultant;
- D. The Municipal Clerk is hereby directed to print and publish a notice of the this award of this contract in accordance with N.J.S. 40A:11-5.
