ORDINANCE NO. 14-2012 OF THE CITY OF BURLINGTON CLOSING A PORTION OF WILLIAMS STREET BETWEEN MITCHELL AVENUE AND COLUMBUS ROAD IN THE CITY OF BURLINGTON

WHEREAS, there exists in the City of Burlington Williams Street, existing solely within the boundaries of the City of Burlington, within and adjacent to the Knitting Mill area of the City of Burlington Redevelopment Plan; and

WHEREAS, this public right-of-way containing a roadway known or formerly known as Williams Street is or will no longer be in use as the result of the redevelopment of the Knitting Mill area; and

WHEREAS, there exists a need to close a 458' +/- foot long portion of the said roadway from public access and public service, the same being a portion of Williams Street lying between Mitchell Avenue and Columbus Road; and

WHEREAS, to better serve the public interest of the citizens of the City of Burlington, the Common Council for the City of Burlington is desirous of closing the aforesaid roadway;

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of Burlington that a 458' +/- foot long portion of the 60' foot wide public right-of-way containing Williams Street, lying between Mitchell Avenue and Columbus Road be and hereby is closed to public access and removed from public service;

BE IT FURTHER ORDAINED that the official tax map of the City of Burlington shall continue to depict the 458' +/- foot long portion of the 60' foot wide public right-of-way containing Williams Street, lying between Mitchell Avenue and Columbus Road that is hereby closed to public access and removed from public service;

BE IT FURTHER ORDAINED that this ordinance shall take effect upon final passage and publication as required by law.

Emma Jean Morgan, 1517 Chestnut Street asked about access to William Street, a lot of people use that road way.

Council Comments

Councilman Ghaul- we have an ordinance closing a street; asked if the City needs to follow the City ordinance in reference to vacating a street.

Mr. Saponaro- we have not vacated it yet; it is closing.

Councilman Ghaul- we will be closing the street; do we need to follow the City ordinance that says you must notify all residents by certified mail and get a report from Public Works, Fire and Chief of Police; all of these reports are required for vacating and closing a street; just asking if the City has to follow the procedure of the ordinance.

Mayor Fazzone- vacating and closing are two separate things; we need to be concerned with the popular definition and actual legal definition, sometimes we draw conclusion based on terms that we use daily but are really are not terms when we are talking legality and engineering reports and those kind of things.

Councilman Ghaul- it is very easily to see; now besides not following Policy Procedure Manual, we don't have to follow the ordinances; will proceed further with that.

Mr. Saponaro- you can close a street; vacating is the legal definition; vacating would be basically giving to a property owner.

Councilwoman Hatala asked if the traffic will be going to go thru to Columbus Road.

Mr. Saponaro- yes.

Councilman Conaway- based on the 2010 vacation, or closing, was this in the Master Plan, as one of the streets considered to be closed?

Mayor Fazzone- we cannot see in the future what opportunities, but yes, it is a possibility.

Resolution No. 188-2012

A Resolution Authorizing the Administration to Submit an Application for a National Boating Infrastructure Grant

Whereas, the National Boating Infrastructure Grant Program (NBIG) Tier 1 is a federal program which provides funding for the development and maintenance of boating infrastructure facilities for transient, non-trailerred recreational vessels at least 26 feet long operated primarily for pleasure; and



Whereas, the National Boating Infrastructure Grant Program is administered by the United States Department of Interior, Fish and Wildlife Services; and

Whereas, the maximum Federal cost share for a NBIG Tier 1, Basic Grant is 75 percent of the total allowable cost up to \$100,000; and

Whereas, the *2010 Master Plan* encourages the development of “the riverfront to provide opportunities for increased visitors through boat docks and ramps, fishing piers and related water oriented uses and ecotourism possibilities.”

Whereas, the City of Burlington has planned for a Municipal Transient Marina on the Delaware River that meets the qualifications of the NBIG Program; and

Whereas, said grant will help fund a priority project in the City of Burlington;

Now Therefore, be it resolved that Common Council of the City of Burlington authorizes the Administration to submit an Application for a National Boating Infrastructure Grant – Tier 1 Application.

**PUBLIC COMMENTS**

Karen Robins, 139 New Bold Corner Road, Vincentown, N.J.- request that the Mayor reconsider his decision not to allow for any exception to his Executive Order; spoke of her wish to proceed with plans to develop Burlington Island.

Kim Law-Jackson, 15 E. Federal Street- requested that the lights on the City Hall building side of E. Federal Street be turned on at dawn for safety reasons.

Robert Hasty, 1818 Hazel Avenue, Bristol, Pa.- expressed opposition of the Mayor's Executive Order not allowing anyone on Burlington Island.

Harry Heck, 116 E. Union Street- sad that only 9 residents are in the meeting tonight; spoke in opposition of Williams Street; suggested that the residents of Ward 2 don't want it; spoke in opposition of more rental units in connection with the Mitchell Avenue Redevelopment Project; spoke of problems with his neighbor feeding feral cats; thanked Council for allowing funds for the repair of the clock tower.

## **COUNCIL COMMENTS**

Councilwoman Woodard spoke in response to the closure of a portion of Williams Street; opposed of the closure but in favor of redevelopment in that area.

Councilman Babula - what are the options with the building; spoke in support of the project; it has been sitting vacant for 25 years; Burlington on the decline; people are not lining up to develop this.

Councilman Conaway announced four job fairs; Hiring our Hero's Job Fair in Trenton September 12<sup>th</sup> , 9-1 at Sun National Bank; Burlington County College Enterprise Center, September 10<sup>th</sup> , 2-6 and Burlington Center, September 21<sup>st</sup> , 10-1.

Mayor Fazzone spoke of research regarding renters; all renters are not bad; many homeowners had to change from being a homeowner to renting; we need to keep an open mind.

Councilman Ghaul suggested that a 30 year abatement is way too long for the City of Burlington; we are giving away the store; closing William Street is wrong; spoke of the bad review from the internet in reference to this developer; the Mayor has a good program in reference to McNeal Mansion; do not feel this is the right project.

Councilwoman Woodard announced that the Community Garden has great free produce; it's free, go out and pick it.

Councilman Ghaul spoke of serving on the Board of Island Managers for 17 years; it has always been no trespassing; the City has not received anything from the Board regarding a redeveloper; agree with the Mayor in reference to no one being allowed on the island.

President Lollar reminded everyone of the Wood Street Fair this Saturday, rain date Sunday; spoke of a Grand Opening Invitation at Torres Studios, they have been in business for 60 years.
